Tuition is based on a yearly fee and divided by 9 months (Sept-May) regardless of number of weeks in a month. If parent or legal guardian fails to notify Dance Expressions of their child dropping all classes, the payment per month is still due. We appreciate your cooperation in this matter. You will receive a studio brochure with confirmation of classes and levels in early August..
